Show Rules & Information

- ◆ All juniors must have a parent or coach present when riding. Coaches must have a signed "permission to treat" medical release if no parent will be accompanying the child.
- ◆ Awards to fifth place. Championships may be offered per division.
- ◆ Management reserves the right to refuse service to anyone.
- ◆ Helmets and proper riding boots are required for those schooling horses as well as those entered.
- ◆ Some stalls may be available on a first come first serve basis. Please call 360.629.9613 to confirm.
- ◆ We have a covered, full size arena adjacent to the show arena available for longeing and schooling at all times. There will be schooling fences set up. There will be no longeing or schooling over fences in the show arena the morning of the horse show.
- ◆ No dogs are allowed. Vehicles containing disruptive animals will be asked to move.
- ◆ Schooling over the course is available Saturday from 2 pm to 5 pm (if you plan on coming please call to reserve a time.) The fee is \$25.00 per horse/rider combination.
- ◆ Class fees will be \$10.00 per round. You may purchase tickets in the office. Tickets will be collected at the back gate prior to each round.
- ◆ Ponies must be ridden by children in pony hunter classes.
- ◆ First round to be judged. Subsequent rounds to be regarded as schooling.

DRIVING DIRECTIONS

GOING NORTH

From I-5 take Stanwood exit #212 head west toward Stanwood/Camano Island. Turn right on 102nd Ave at Bank of America building. Arena is located on right after railroad tracks.

HEADING SOUTH

From I-5 take Lake McMurray exit. Turn right at exit stop and go South on Pioneer Hwy. toward Stanwood. Go approximately 2.5 miles and turn right over railroad tracks on Old Pacific Hwy. Facility located on left 1 mile.
